Pharmacy Policy for Coverage of Non-Preferred Viscosupplements, Effective April 1, 2011

Today, agents within a therapeutic drug class can vary widely in cost, even if they are clinically equivalent and interchangeable. Commercially available products within the viscosupplement therapeutic drug class are considered by most physicians to be clinically equivalent and interchangeable.

Following a comprehensive review of all nationally published information on viscosupplements commercially available and after gathering feedback from impacted specialists, it has been determined that these products have similar efficacy despite wide variances in cost. As announced previously, to help ensure the affordability and sustainability of the medical benefit, **Mountain State Blue Cross Blue Shield has established Supartz and Synvisc as the preferred viscosupplements available through the Mountain State Medical Injectable Drug Program**.

The Mountain State Medical Injectable Drug Program is the program through which Mountain State providers order certain injectable drugs for office administration for their SuperBlue[®] Plus, SuperBlue Select, and Highmark Health Insurance Company (HHIC) FreedomBlueSM PPO patients.

Pharmacy Policies Define Criteria for Coverage of Non-Preferred Agents

Mountain State recognizes there may be instances in which the use of a viscosupplement other than Supartz or Synvisc might be indicated. To address these scenarios, Mountain State Pharmacy Policy J-501 defines the criteria under which coverage for non-preferred viscosupplements will be considered.
